





TO HICKORY WE WILL GO – 2020 EFMLS CONVENTION

The Catawba Gem and Mineral Club invites all delegates and guests to their 50th annual Catawba Valley Gem and Mineral Show to be held in association with the annual EFMLS Convention in Hickory, NC March 27-29, 2020.

The show will be held at the Hickory Metro Convention Center at 1960 Avenue Drive, SE, exit 125 from I-40 east/west. Friday and Saturday show hours are 9:00 am to 6:00 pm, and Sunday show hours are 10:00 am to 5:00 pm. Over 24 quality vendors will have an array of merchandise that includes minerals, fossils, meteorites, finished and unfinished jewelry, and more...hourly door prizes are offered as well as demonstrations of faceting/ cabbing/wire wrapping, kiddie mini-mine, hands on exhibits for children, educational tasks for school groups—competitive and non-competitive exhibits will be shown for the public's education. The special-feature exhibit will be The First Gold Rush in North Carolina.

SAFETY MATTERS – A Difficult Topic

It is a difficult topic to talk about, especially in polite society. It's rife with uncomfortable situations. It's dripping with implications. It's also lifesaving. What is it? It's sweat, or rather perspiration.

Our bodies sweat, pardon me, we perspire for numerous reasons. But they all lead to the same result, we lose valuable water, salt, and various other chemistries.

There are times we don't know we are perspiring, such as after we have been swinging the 15 pound sledge hammer for a while and the perspiration starts entering our eyes causing us to loose the ability to see what we are trying to hit with the hammer. So, what do we do then? We wipe our brow, dry our eyes, and go back to swinging. We have, after all, a good measure of passion in our hobby.

It's usually a while later when we decide we are thirsty and take a break to replenish ourselves with a drink of water, but by then, we are already dehydrated. When we are thirsty, we are already dehydrated. Our body is already unbalanced by lack of precious water.

I'd like to make a case for drinking water before we are thirsty, making a case for drinking as we go, rather than waiting till we feel thirsty. When we anticipate engaging with an activity likely to cause perspiration, I'd like to make a case for keeping handy a bottle, a cooler, a thermos, an ice chest, a Thermos, an insulated bag or whatever containing a sufficient quantity of bottled water. If one is to perform the perspiration-causing activity indoors, perhaps displaying a reminder sign nearby with the single salient words "Drink Water" would be in order. That might remind us to frequently utilize nearby sources of drinking water.

Keeping our bodies hydrated is important for just about everything we do - thinking, digesting, cardio-vascular activity, movement and joints, and so on. If we are unbalancing our bodies with lack of water, we are making whatever activity with which we are engaging that much more difficult. For our bodies' sake, drink up!

One other important consideration is what we drink. While soda, soft drinks, pop, coffee, energy drinks, tea, alcohol-including drinks, all contain water, they also contain other chemistries, chemistries which affect our bodies. Pure water is hard to beat for optimum performance in most situations. For one thing, the other drinkable options have additional chemistries, ones which alter how we process the drink. They add work to process. Water is simpler. When thirst calls, water answers.

Before thirst arrives, please drink up and replenish your body. Keep your body at optimum operational levels. Drink and be cool.

SAFETY MATTERS - Is Safety Enough?

A question, if I may. Do you think just wearing eyeglasses is enough to protect your eyes? The answer is well, maybe, maybe not.

There is a discussion going around -- does wearing seat belts while driving one's car make one feel safer or perhaps more confident about the driving? And, if one is feeling safer more confident, is it possible that with such feelings, might one drive faster or perhaps not as cautiously because of using the

aforementioned seat belts? There is a discussion in safety circles as to whether or not the potential of additional risk taking might mitigate a portion of the safety from use of the belts. Again, this is not a discussion as to whether or not to wear seat belts. Seat belts are well documented as to their benefits in saving lives and reducing injury in motor vehicle accidents. This is instead a discussion as to the idea that, in addition to the belts, we should consider how we feel about relying on them to get one out of trouble if it should happen upon us. In other words, seat belts are not the whole answer, they are a compliment to all of our good driving practices.

Oh, and of course, there are folks who will not change their driving habits one single iota while wearing their seat belts. They will remain as cautious and risk averse as is their usual nature. They will as usual mind the speed limit, will drive just as carefully in the snow even though they have snow tires, and will be just as cautious in every respect.

So, where do safety glasses enter his discussion? When one is wearing their safety glasses, are ones hammering actions more dramatic on the chisel? Is one as careful as usual about other people in the area while chisel chips are flying? Might one be as fussy about large flying shards while striking a rock directly with the hammer? Safety shoes, might wearing safety shoes cause one to be less careful of their footing? One may still lose their footing even while wearing the best of boots. Gloves, gloves should not be counted on to fully protect ones hand during a hammer's mis-strike. Ones fingers may still suffer a hurtful pinch right through a heavy glove.

The take away is to remain mindful even though one is wearing or utilizing every item of safety gear available. Try not to let using safe gear override one good safety practices - you can do this.

GREETINGS FROM THE KANAWHA ROCK & GEM CLUB!

The Kanawha Rock and Gem Club has been around for almost 50 years. The need of an organization was felt after a small group of people interested in the hobby of working with and collecting rocks made a trip in May of 1972 to hunt coral agate in the Lewisburg area of West Virginia.

Since that time our club has gone through good times when membership was well over 150 to bad times when it looked like we would fold. But we are a tough lot and still standing tall.

Today our club is very active and growing. At every monthly meeting our Junior Geologists spend an hour with their leader, Sue Williams, learning about geology, paleontology, minerals, and the lapidary arts while earning badges from the AFMS for their accomplishments.

While the Junior Geologists are meeting it is social time for the adults. We swap stories and specimens, buy and sell and brag about our recent finds. Karen Gorby makes sure we never get hungry and we always have plenty to eat and drink.

Next comes the business meeting where upcoming events and club happenings are discussed. We always have a presentation, after the business meeting, scheduled by our Vice President Linda Johnston. This year some of the things we have learned about are Ancient Moundbuilders in our area and the artifacts that have been found, Ordovician Fossils of the Cincinnati region, Tombstones, Materials, history and Fabrication, the History of Chain Maille, holistic crystals, and much more. All presented by experts in their field. After the presentation the meeting is called to a close, but it's not over yet. We have a Post Meeting Project, or PMP. Every month a member volunteers to teach other members a skill that can be competed in a short amount of time. It is usually jewelry making, but we have also learned about flint knapping, identifying minerals or discussing tools.

We have a good camaraderie within our membership, and we like learning and doing things together. Especially with our field trips and formal classes.

This year we have traveled to Kentucky in search of Agates in Estill in April, to Maysville to find Ordovician fossils in May, and to Mammoth Caves in August for an overnight camping trip. We have been to a local museum to learn about ancient cultures, and to Pittsburgh, PA to visit the Carnegie Museum of Natural History. We really like to go places with over 8 trips so far this year, and 3 more planned.

Our classes are taught by a professional or by a member, and sometimes both! Our members teach chain maille, flint knapping, and the cabochon making classes, we call it 'Slabs to Cabs'. We have professionals to teach Dichroic Fused Glass, Wire Weaving, and others. Franko, of Franko Wire Wrapping and a member of our club, teaches our wire wrapping classes.

The Kanawha Rock & Gem Club also gives to the community by making presentations to public schools, private schools and groups of home-schooled children. We teach the Boy Scouts and the Girl Scouts about the Mohs Hardness Scale. We do community outreach programs for libraries and other public programs with simple lapidary projects that the makers can be proud of.

The Annual Rock, Gem, Mineral, Fossil and Jewelry Show and Sale on the 3rd weekend in October is our only fundraiser. We bring in vendors from across the country to sell and display crystals, mineral specimens, jewelry, fossils, and lapidary services. That's only to keep the parents busy while the kids are having fun making crafts, sifting through our Mini-Mine, scavenger hunting and cracking geodes. Our guests can also pan for gold and learn soapstone carving and watch demonstrations of cabochons being made and wire wrapping and flint knapping.
